Cisco announces the end-of-sale Cisco RV132W and RV134W Wireless-N VPN Router. The last day to order the affected product(s) is October 19, 2020. End-of-Life Announcement Date	The date the document that announces the end-of-sale and end-of-life of a product is distributed to the general public.	July 20, 2020
End-of-Sale Date: HW	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	October 19, 2020
End of Phone Support: HW	The last date to receive phone support as part of the product warranty. After this date, all phone support services for the product are available with additional charges or support fees. In some cases, support may not be available.	October 19, 2021
